#### **Admissions Requirements:**

Students wishing to enroll in the TN Professional Training Institute's 85 Hour Phlebotomy Program must meet these admissions criteria:

- Must be 18 years of age or older, as required by the Tennessee State Board of Dentistry
- In good standing with no felony convictions. Misdemeanors are not immediate disqualifiers.
- Willing and able to work with patients while giving the best patient care possible.
- Must be a high school, G.E.D or HiSET graduate and submit OFFICIAL transcripts indicating date

#### **Attendance Requirements:**

TN Professional Training Institute's Phlebotomy program is an intensive, accelerated, 85 - hour program. Students who miss any class time may be moved to the next session at the discretion of the instructor.

#### **TNPTI Code of Honor:**

**Code Defined:** It is presumed that any student who enrolls at TN Professional Training Institute is willing to conform to a pattern of mutual trust and honor and shall deal honorably with all members of the TNPTI community. #### **Refund & Cancellation Policy:**

Students enrolling in the TN Professional Training Institute's Phlebotomy course are eligible for a full refund if the student withdraws from the TN Professional Training Institute on or before the first day of classes or fails to begin classes. The refund shall equal the sum of all amounts paid or to be paid by or on behalf of the student for the period of enrollment, less an administrative fee of one hundred dollars (\$100.00).

If, after classes have commenced, a student who has enrolled in the TN Professional Training Institute's Program withdraws, drops out, is expelled or otherwise fails to attend classes after the first day and until 25% of the course is in session, the student shall be refunded twenty-five percent (25%) of all amounts paid or to be paid by or on behalf of the student for the period, less an administrative fee of one hundred dollars (\$100.00).

If, after classes have commenced, a student who has enrolled in the TN Professional Training Institute's Program withdraws, drops out, is expelled, or otherwise fails to attend classes after 25% of the course is in session, the student is responsible one hundred (100%) of the tuition, fees and other charges assessed the TN Professional Training Institute **and will not be issued a refund.**
